

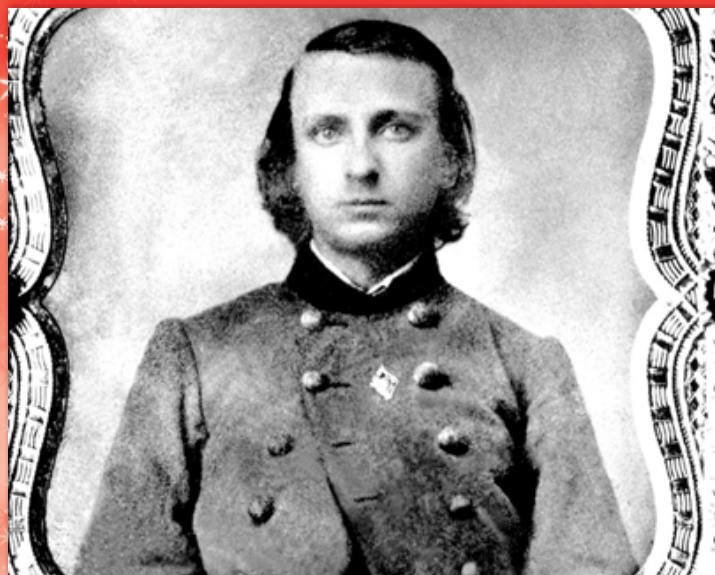

## 2nd Lt. Samuel Sydney Gause, Jr.

Sydney Gause certainly had an interesting life, full of highs and lows. The highs included a good, well-to-do family, good education, professional status, service as an officer in the Confederate Army, good marriage, fine children, success in business, and community status. The lows included loss of his mother at an early age, four years of hard war, away from family and loved ones, loss of a child, financial problems, and business failure. It was definitely interesting, and not at all ordinary. It is the story of "Everyman," some successes, some failures, but constant striving, and in his case at least, an honorable, if early, end.

that have done your duty, thanks to each of you for all that you continue to do for our Confederate ancestors. I greatly appreciate Memphis Brigade Commander Mark Buchanan's commentary in this edition of the Forrest Escort; I hope that it will give each of you inspiration as we get ready for 2018.

Thanks to each of you that were able to make the Tennessee Historical Commission meeting in Athens. We still have a never ending battle in Memphis, and never know what tactic will be pulled by the Memphis City Council. Thanks to all the boys in Memphis for keeping the Skeer on em'. As most of you have heard, we did have a bad ruling on the Memphis Park renaming. The Save our parks group is assessing the ruling to determine if they should continue their appeals. The next THC meeting will be on Friday February 16th in Nashville, we will have more details available as soon as the information is released by the THC.

We have been fortunate here in Tennessee to have the Heritage Preservation act of 2016 in place. Unlike states and cities across this country that have desecrated history by removing Confederate and other monuments, here in the Tennessee we have had the law on our side. This law does apply only to government owned properties. Unfortunately at Sewanee University, which is a private institution, it has been decided to move the General Kirby- Smith plaque from Texas and University Avenue to the cemetery where he is buried on campus. This plaque has been in place for over 80 years and was placed by the UDC. This is just one of many instances where we need members to get involved on boards and committees in their local area.

The Tennessee Heritage PAC is registered and fully operational. Mark Buchanan is the Chairman of the Committee, if you are interested in donating to the PAC please contact Mark at: marksouth1861@yahoo.com for more information. The SCV, whether it is the National, Division, Brigade or Camp level cannot donate to this PAC or endorse any political candidate. However, as individuals you can donate however you wish. With the anti-Confederate movement that it this country the past few years, this PAC is a very important, please consider giving your support. Today's battlefield is in the courtroom and with legislators.

The Sam Davis a Hero Remembered event was November 18-27 at the Sam Davis home in Smyrna. On Sunday November 19th 3 pm, there were over 50 in attendance for a memorial service at the grave of Sam Davis. SCV CIC Tom Strain was in attendance. A Polk Corps flag now flies year round from the office, a wreath with Confederate flags stays on his grave year round and for the Memorial Week, a 5' x 8' First National hung from the balcony of the main house. A post on the Sam Davis a Hero Remembered Facebook page generated over 13,000 views!

Confederate Flag Day will be Saturday March 3rd 2018; I hope that each Camp will plan a flag rally in their area. Just as we did last year, as many Camps as possible caravan from your chosen location and we will have our rally point at the Forrest home in Chapel Hill at 2pm.

Be sure to mark your calendar for the Tennessee Division reunion at Henry Horton park in Chapel Hill April 20-21, 2018. This next year will be an election year, if you are going to run for an office please announce it in the Forrest Escort. This will give others an opportunity to decide if they will run for office. I will be running again for Tennessee Division Commander.

Also, please send in nominations for the Tennessee Division awards this year. It seems that we barely have enough entries to hand out the awards.

## By-law Change Update

### ARTICLE III - MEMBERSHIP & DUES

#### Current:

Section 4 - Dues shall be due and payable to the Adjutant, Tennessee Division, (remove) no less than seven (7) days prior to the announced date of the Division Convention, in order for Camp delegates to be allowed. A roster of all paid members will accompany the payment of dues.

#### Change to:

Section 4 - Dues shall be payable to the Adjutant, Tennessee Division, (add) on August 1st of each year, with a 1 month grace period from August 1st through September 1st. Camps dues that are in arrears 60 days prior to the Division Convention will not have voting privileges at the Division Convention. A roster of all paid members will accompany the payment of dues.

The SCV Tennessee Division operates on a fiscal year beginning August 1st of one year and going through July 31st of the following year, annual. This change brings the Tennessee Division in line with the National dues deadline and eliminates the Tennessee Division Adjutant from waiting eight months to receive Camp dues from the actual dues date.

This amendment has been changed since it was first proposed; after input from several members, the Tennessee Division late fee has been withdrawn.

# To Members of the Tennessee Division...

The Sons of Confederate Veterans is dedicated to the preservation of the Confederate Soldier's good name, and in Tennessee we continue the fight to do that. Every day we accomplish this goal by testifying to our friends, neighbors, co-workers, fellow church members, politicians, our families and even strangers we meet in our daily lives. We also meet with each other to fortify this spirit and help expand our knowledge of those great warriors of the South. We erect monuments to their bravery, fly our flags proudly and stand up to those who would destroy or defame our Confederate heroes. There is no question, our Confederate Soldier has been under a lot of fire lately. From one end of the country to the other, monuments, flags, markers, statues are being destroyed, vandalized and sometimes even worse, they are being "contextualized". There are also those who would repeal laws that protect our American heritage.

As of late, there has been some bitterness, anger and malaise over how things are going. We ask ourselves, "Are we doing enough, are we doing the right things, do we have the right people in the right places to achieve our goal? Should we spend the money to fight this fight or that fight? Do we stand in the street with a flag and a sign or do we use the ballot box and the keyboard to protect our heritage?"

Let us take stock. The Tennessee Sons of Confederate Veterans has held off the forces of destruction since 1999. Eighteen years folks! Do you know what "they got"? Two park names and a marker removed. That is it. What did we get? We gained legal standing in the court of law for ANY heritage organization to take our opponents to court to stop them. This was accomplished in a Tennessee Appeal Court ruling that granted us legal standing in a unanimous decision! Former state Attorney General Summers said it was "unprecedented"!

We passed not one, but TWO new heritage laws that have strengthened our position in the court of law and before the Tennessee Historical Commission. We have more members on the THC than any time in recent history. The city of Memphis has applied for waivers to the Heritage Law twice. THEY HAVE BEEN DENIED TWICE. The last denial was by an overwhelming majority on the Commission! There were pro-history votes from people who might not ordinarily side with the Confederate soldier but we presented our case so well we carried the day. These rejections to the city came in the face of the pleadings of the Memphis mayor, lawyers, liberal millionaires, local clergy, the city council and the county commission and local activists who monopolized the meeting! But RIGHT and the SCV prevailed. Our heritage law became the blueprint for Alabama's law, which has prevented the destruction and removal of monuments in that fair southern state. We tried it in Louisiana but couldn't get it done. But we haven't given up!

We stopped the removal of the Forrest Bust in the state capital and the destruction of the A.P. Stewart bust in Chattanooga. The state NAACP said it wasn't worth the trouble! How did this happen? By our SCV members showing up at the THC meetings, writing our legislators and making a big fuss! (politely) The powers that be know we are out here brothers! WE ARE A FORCE IN TENNESSEE!

We staved off an assault by Governor Haslam to remove the Forrest bust, the Forrest Statue, and to end the issuance of the SCV License plate. Not bad my Compatriots, not bad! As icing on the cake, that scallywag is not running for any office in the state in 2018. I will let you draw your own conclusions.

We recently created a Political Action committee separate from the Sons of Confederate Veterans. We have already met with an excellent gubernatorial candidate, and are scheduled to meet with another in January. THE CANDIDATES WANT TO TALK TO US! CAN YOU BELIEVE IT? It's because we care, we are active, and we vote.

This past July we held one of the best National Sons of Confederate Veterans Reunions with great attendance especially in light of the fact that it wasn't even an election year. We brought \$1.35 million to the local economy. We aren't done yet; we are holding another National Reunion in Franklin, TN in 2018. This follows other excellent successful Reunions in Murfreesboro in 2012 and Memphis in 2002. WE GET THINGS DONE.

Have we had reverses? Sure, but even the great Robert E. Lee didn't succeed all the time. Recent comments to the Memphis Brigade site congratulate us on being one of the Divisions that is winning. We have a lot to be thankful for. We have done great things over the last few years. We have great, dedicated members who are advancing the Charge and fighting the good fight. It is easy to see all the bad news from across the country concerning Confederate Heritage and start to feel disappointment and frustration. But the Tennessee Division is a leader in preserving Confederate Heritage. We have much more to do. Our enemies are legion and our numbers few. Now is the time to rededicate ourselves, take a deep breath and dig in. We must take our cause to the floor of the statehouse by electing great people. We need to concern ourselves with the candidates for Judgeships across the state as we will see more and more of our fights show up in the court system. It stands to reason we need good people in place. We must run for/join commissions, councils and committees that have sway over parades, public spaces, libraries and SCHOOLS. Rest assured our enemies are already there; we MUST meet them in force.

In closing, stand up straight Tennessee! Hold your head up! You have done yeoman's work. Let yourself feel good about all you have accomplished since all this started. GREAT JOB MEN! ## Alexander Houston Sanders

Alexander Houston Sanders was born on September 20, 1838 to Jacob and Martha Yates Sanders in the Payne's Cove Community in Pelham, TN. At the start of the War Between the States, he enlisted in the First Tennessee Infantry, Co. A. under Col. Peter Turney. After the battle of

Gettysburg, Sanders was authorized to return home and raise what would become Company C., Twentieth Confederate Cavalry.

Captain Sanders, as he would now become, was involved in such battles as; 1st and 2nd Bull Run, Yorktown, Seven Pines, Fredericksburg, Chancellorsville and Gaines Mill. He would go to receive several wounds in battle. At Harpers Ferry he was shot in the arm, a broken leg due to a gunshot in Alabama, and in McMinnville, TN he was shot through the lower part of his jaw and chin and shot in the thigh. He also received

severe saber wounds to his hands when his weapon was cut in pieces and he had to fend off blows with his hands.

Reports show that after returning home due to illness, he joined Meade's Partisan Rangers, Co. I., and later became a member of the 28th TN Cavalry. After the war, A. H. Sanders was elected to the county court in Grundy County where he served for eight years, and was then elected to sheriff of Grundy County. Alexander Houston Sanders is buried in the Old Baptist School Cemetery in Pelham, TN.

Murfreesboro SCV Camp #33 will hold their annual Battle of Murfreesboro Memorial service on Sunday December 31st 2017 1:00 pm at the Confederate Circle in Evergreen cemetery. The cemetery is located at 519 Greenland Drive in Murfreesboro. Reenactors are welcomed to participate in this memorial service, everyone will be under the command of Camp #33 Honor Guard Sargent Kurt Huskey. Everyone is invited to attend.

This memorial service is held in memory of the Confederate s killed in and around Murfreesboro during the Battle of Murfreesboro (Stones River for the Yankees) December 31, 1862—January 2, 1863. There are over 2,000 Confederates buried in this mass grave.



## 2nd Lt. Samuel Sydney Gause, Jr.

From the biography: SAMUEL SYDNEY GAUSE, JR.,

When President Lincoln called on all states, including the remaining southern states, to furnish troops to crush the "rebellion" of The Confederate States, the sentiment in the Border States, including Arkansas, turned swiftly from anti-secession to pro-secession. While those states were

not willing to secede over Lincoln's threat to the western expansion of slavery, they would secede to avoid going to war against their Southern neighbors.

The next year of Sydney Gause's "interesting life" is unusually well-documented, due to the fact that he wrote his own 3-page "Condensed Synopsis of Our Proceedings in Virginia," in his surveyor's field book, and especially to the existence of a much longer and more-detailed book, *Reminiscences of a Private*, by W. E. Bevens, a member of the same company in the Confederate Army.

When it became obvious that Lincoln would invade The Confederate States to force them back into the Union, and that war was inevitable, and that Arkansas would probably secede, Captain A. C. Pickett, a Jacksonport lawyer and Mexican War veteran, raised a company of about 120 men and called it "The Jackson Guards." The ladies of Jacksonport made them a fine silk flag, about five feet by nine feet in size. It was of the "Stars and Bars" pattern, or First National Flag, with a ninth, and larger, star, representing Arkansas, in the center of the circle of eight stars representing the eight Confederate States then in existence, although Arkansas had not yet seceded. It also had a blue square in the center of the white bar, with the words "Ladies of Jacksonport to The Jackson Guards" in white on it. It is shown in Figure 11,

On May 5, 1861, the company formed ranks and marched to the Presbyterian Church in a driving rain and took their reserved seats. The whole town turned out, packing the church and standing outside in the yard and streets in the rain. The young ladies who made the flag were arrayed in seats on the platform. According to Bevens, "Miss Mary Thomas Caldwell presented the colors with a short and touching speech. Sydney S. Gause received it in the name of the company, replying beautifully."

As quoted in *The Jacksonport Herald* for May 1861, Miss Caldwell's address was:

"Gentlemen: permit me in behalf of the ladies of Jacksonport to present you this stand of colors as a token of their appreciation of your valor and the cause you have so nobly espoused. The additional star in the galaxy is in hopes that ere this is unfurled to a southern breeze, our own noble state may be added to the constellation of the South. Never suffer its folds to trail in the dust, but may its presence on the field of carnage remind you of the loved ones at home, and

nerve you to deeds of valor. May the god of battles attend the Jackson Guards and crown their expedition with victory and safe return to the bosom of their noble Jacksonport."

Sydney Gause replied:

"*Ladies of Jacksonport: It is with the most pleasing, yet profound emotions, that I, in the behalf of the Jackson Guards, return to you our kindest thanks for the respect you have shown in presenting the company a flag under which to rally and fight when the slogan of war has sounded from the hilltops of New England to the home of the southern planter.*

"*With this flag we go to meet the enemy, and when the painted horrors of the field of carnage have become reality, we will in those perilous times feel as we look upon this gift, that although the arm that offered it is too weak to strike, yet the hearts that gave it bat warm and for the same cause for which we now offer our lives.*

"*In receiving this sacred treasure from your hands, and the kind words of encouragement which you have given us, we hope to carry it into the very heart of the enemy's country, to plant it there and let it float from the turrets and towers of every city North, or be permitted to fall beneath its folds, In defending it and the interest it represents, we had rather fall like men, "with our backs to the field and our feet to the foe," and be buried in the humble mound that contains the bodies of our fellow soldiers, than to die amid the rich drapery of a palace, and be entombed in the grand mausoleum in which slumbers the royalty of the world.*

"*We again return to you our heartfelt thanks for the distinguished honor you have done us, and we assure you that our highest ambition, is that would we be permitted to return, although tattered and smoked it may be by the rude elements of war, that we may replace in your hands crowned with the most glorious victories and lay our trophies at your feet."*

After saying their tearful goodbyes, many for the last time, as it would turn out, the company marched the short distance to the river and boarded the steamboat *Mary Patterson* of Captain Morgan Bateman, who took them to Memphis for free. Sydney Gause had still not paid for the clothes he bought in January.



Editors note: General Robert H. Hatton Camp member, Edward Thackston, has compiled a biography of his ancestor, 2nd Lieutenant Sydney Gause. He has forwarded me a copy of this well researched and illustrated biography. While there is not room here to do his research and writing justice, I have chosen a short passage that talks about the presentation of the company flag by the Ladies of Jacksonport. His ancestor gave part of the address. I can well imagine a similar ceremony with heartfelt speeches would have occurred all across the Confederacy as its young men were called to take up the cause.

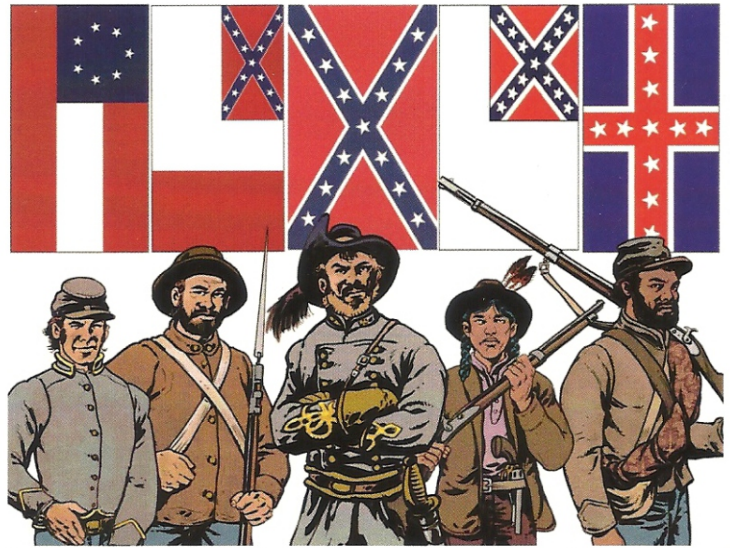

### Tennessee Heritage Protection Act Of 2016

SB2138: Any public real property or park, preserve, or reserve located on public property that has been named or dedicated in honor of any historic conflict, historic entity, historic event, historic figure, or historic organization; or any statue, monument, memorial, bust, nameplate, plaque, artwork, flag, historic display, school, street, bridge, or building that has been erected for, named, or dedicated on public property in honor of any historic conflict, historic entity, historic event, historic figure, or historic organization; may not be removed, renamed, relocated, altered, rededicated, or otherwise disturbed or altered.



### Tennessee Confederate facts

There were 135,812 Confederate soldiers from Tennessee.

270 African-Americans received a Confederate pension from the State of Tennessee after the War Between the States.

There were over 1,400 Battles and engagements in Tennessee during the War Between the States.

Thomas' Legion, a Confederate unit organized in Knoxville, Tennessee, was made up of several hundred Cherokee Indians loyal to the South.

There are over 70 historical markers dedicated to Confederate General Nathan Bedford Forrest across Tenn.

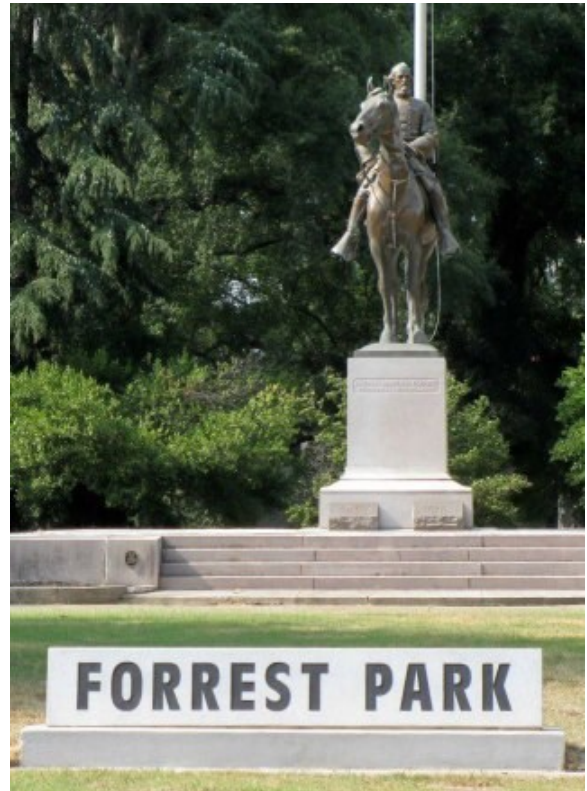
